### INTRODUCTION

Harmony Software LLC ("we" or "us" or "our") respects the privacy of our users ("user" or "you"). This Privacy Policy explains how we collect, use, disclose, and safeguard your information when you visit our website keystonebit.com or use any of our applications, including any other media form, media channel, mobile website, or mobile application related or connected thereto (collectively, the "Site"). ### **COLLECTION OF YOUR INFORMATION**

We may collect information about you in a variety of ways. The information we may collect on the Site includes:

#### **Personal Data**
